- **A**. Shea Greiner for annexation updates: Meeting with Mahaska County supervisors two weeks ago and all three were in favor of the annexation. Shea asked council and Clay if we had enough municipal services including public safety and fire for the expanded areas. Clay stated that we did and the council agreed with the services we have we do have enough for the expanded areas. School board meeting will be in a couple of weeks. Shea showed the plat map of the new area and the description for the annexation.

Would like the city to have own account at the landfill for this project. Mid-American Energy gas meter is still there. One call is marked for all. The front sidewalk bad shape. Take sidewalk out so not a trip hazard. City will put new one in when finished with this property. Adam said he will do best to pick up anything that blows around. Approximate cost \$13,500 not including landfill charges is best estimate at this time.
